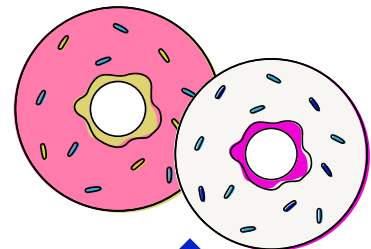

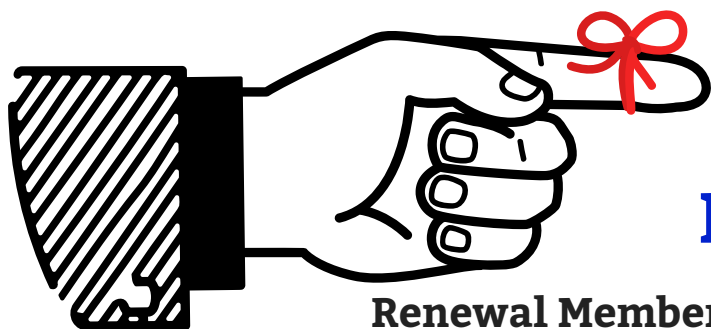
# Legislative Committee Update

**You recently received a survey request from the Legislative Committee who is working toward presenting three proposed bills to the legislature in the upcoming session. Through our lobbyists, Ted and Julie Mullinex, we will be introducing bills to solidify Respondents' subrogation rights under the Act, create a cap for Death and Permanent and Total Benefits and to help clarify the ability to dismissal of claims that aren't being pursued through litigation. Our legislative committee will be looking to the membership for help in gaining approval of these bills by the legislators and assisting in getting them passed. Without the assistance of our member companies in pushing these initiatives we likely won't prevail.**
